Who are we?	<p>TipTap is a mobile application (“app”) from TipTapIt LTD (“us”, “we” or “our”) which allows consumers to allocate tips for service directly to workers (the “service”).</p> <p>If you have any questions please contact us at hello@tiptapit.com</p>
Basic terms	<p>If you wish to become a user of TipTap please read and consider these Terms of Use (“terms”) carefully. Follow the instructions in the sign up process to indicate your acceptance of these terms. Use of the app is conditional on you accepting these terms, and these terms form a binding contract between you and us.</p> <p>Please note:</p> <ul style="list-style-type: none">- these terms will be governed by the laws of England and Wales, without regard to its conflict of law provisions are between you and us and you agree to them by using the TipTap app.- you must be over 16 years old to use the app.- if we close your TipTap account due to use that is not in line with these terms, you may not create another account.- your account is personal to you and is non-transferable.- you may only create one account.- each time you access and/or use the app, you agree to be bound by these terms and any additional terms that will apply to you.- you should read these terms along with our privacy policy. <p>These terms (and any updated versions) will always be available for you to view on our website and/or in the app. You agree that we may provide notice to you of updated terms by posting them on the app and on our website. If the changes to the terms are significant we will notify you using the email address that you have provided to us. If you don't agree to updated changes, you can let us know and we'll close your account.</p>
